

**FOURTH AMENDMENT TO THE  
COVENANTS, CONDITIONS AND RESTRICTIONS  
OF  
GRANDEL FOREST ESTATES AND WOODS OF FEYHURST

WHEREAS, the Declaration of Covenants, Conditions and Restrictions herein were originally recorded in Deed Book 8353, Page 577 dated February 10, 2004, and a First Amendment was recorded in Deed 8385, Page 481, on April 5, 2004;

WHEREAS, the undersigned, President, Vice-President and Secretary, of Grandel Forest Estates and Woods of Feyhurst Joint Community Association, Inc., certify that pursuant to Section 17 of the Covenants, Conditions and Restrictions of Grandel Forest Estates and Woods of Feyhurst Joint Community Association, Inc., this amendment was adopted by a vote of more than two-thirds of the lot owners;

NOW THEREFORE, the Fourth Amendment to the Covenants, Conditions and Restrictions is added as follows:

No all-terrain vehicle, dirt bike, off-road vehicle of any kind, but not limited to all-terrain vehicle or motorcycle or ultra-light airplane, shall be operated on any lot at any time. Such vehicles may only be stored on any lot if properly stored and may only be operated to the minimal extent necessary to load such vehicle onto a trailer or truck in order to transport it to and from the lot.


